

Agency Furloughs by Date

Due to the national economic crisis and the impact on State revenues, the State of Wisconsin is requiring that all state employees take eight days of furloughs for each of the next two fiscal years. Of those, the State has designated four days in each fiscal year when agencies will close offices to the public. To accommodate operational needs some agencies have designated alternative dates to close offices, have designated additional days to close offices or will remain open on the State designated dates.
